

- 1 Addition/ alteration in the premises as sanctioned vide letter no F6/DFS/MS/BP/2018/198 dated 25/06/2018 is under progress same shall not be occupied without getting clearance from this department.
- 2 All the fire safety arrangements provided therein shall be maintained in good working condition at all times.
- 3 Any loss of life or property due to non-functional fire safety measures shall be at the risk and responsibility of the management.
- 4 The trained staff should be available round the clock.
- 5 Any deviations w.r.t. construction shall be verified by the concerned building sanctioning agency.
- 6 The certificate may not be treated in any case for the regularization of the unauthorized construction, if any.
- 7 The owner/ occupier shall apply for renewal of this Fire Safety Certificate to the Director in Form 'J' [sub rule (1) of rule 37] along with a copy of this certificate, six months prior to its expiry.
- 8 Basement shall be used strictly as per building bye laws.
- 9 The owner/occupier shall submit a declaration every year in the form 'K' provided in the first schedule of Delhi Fire Service Rules 2010, form is available on www.dfs.delhigovt.nic.in
